Eudaimon, registered in The Netherlands under Chamber of Commerce (KvK) no. 98546376, operates the website www.eudaimon.nl (“**the Platform**”). By accessing or using the Platform, you agree to these Terms of Use. Please read them carefully before registering or using any subscriber features.

1. Scope of Use

You may browse the public parts of the Platform for personal, non-commercial purposes. Access to subscriber sections requires registration and an active subscription (free or paid). You may not use automated systems, bots, or scraping tools to copy or extract content, nor interfere with the Platform’s functionality.

2. Accounts and Subscriptions

- You must be at least 18 years old to create an account.
- You are responsible for keeping your login credentials confidential and for all activity under your account.
- Do not share your account or allow others to use it.
- Eudaimon may suspend or terminate accounts that violate these Terms or applicable law.
- If subscription fees apply, they are stated clearly before purchase; payments are handled securely by our payment provider.
- Paid subscriptions renew automatically each billing cycle (monthly or annually, depending on your plan) until cancelled through your account or by contacting us.
